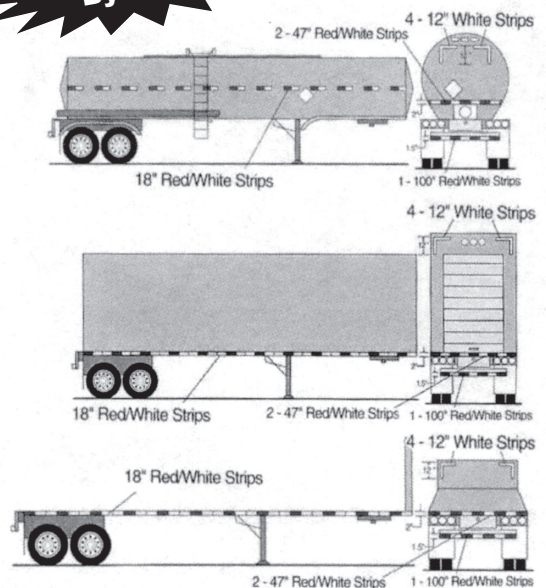
Why Do You Need It?

- Effective in 1999, all trailers must be retro-fitted with conspicuity treatment
- The rule applies to equipment made after December 1, 1993 and are 80" or more wide with a GVWR of over 10,000 lbs.
- Must comply by adding and maintaining the red/white tape

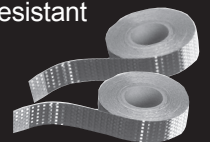
Where Is It Required?

- 50% of the length of the trailer shall be treated with 2" wide or two 1" wide strips applied no further apart than 1"
- Alternating red/silver tape on the sides and rear of each trailer. 12" silver strips in the upper rear corner

As Required By Law



- * Exceeds DOT requirements
- * Durable, impact and solvent resistant
- * Easy installation
- * Reflects light even in daytime
- * Bright prismatic appearance

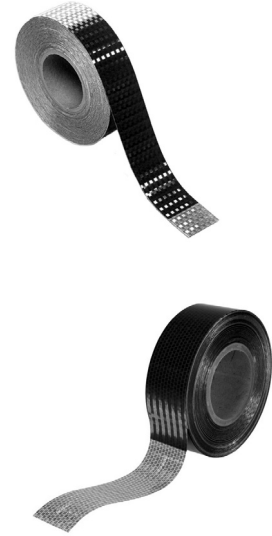
